Introduction (Continued)

- Each state's Board of Pharmacy determines what standards are and how they must be met by technicians
 Technicians throughout the United State
- Technicians throughout the United States will become respected as pharmacy paraprofessionals
- Pharmacy technicians and other trained allied health workers can be called "paraprofessionals," meaning they have been trained to work alongside and assist professionals such as doctors and nurses.

Current Qualifications

- Each state has its own Board of Pharmacy overseen by the Nation Association of Pharmacy
- A Board of Pharmacy registers technicians and licenses pharmacists, and it also provides consumers with a way to complain or report any problems or illegal actions they have experienced in a thermeetic.
- A Board of Pharmacy reviews and updates current rules and regulations pertaining to pharmacy practice; expands use of technicians in the pharmacy field

- Today, state boards of pharmacy are still standardizing the job description for the position of pharmacy technician.
- You might be hired under some title other than "pharmacy technician" for the same duties that you are learning in this program
- The NABP also helps licensed pharmacists change their licenses to another state if they move.
- Because each state has different, constantly changing laws, the NABP maintains a State Pharmacy Law and Rules database

Nondiscretionary Duties

- Technicians perform many types of nondiscretionary duties
 Nonjudgmental means that any task completed in a pharmacy setting must be checked and approved by a pharmacist legither to the pharmacist
- Limits technicians from interpreting scientific studies, counseling patients,

Inpatient Setting Requirements (Continued)

- Stat (emergency) orders: technicians must be able to react quickly when emergency (stat) orders are received
- Stat doses are to be delivered within 15 minutes to the stations requesting them (ER, OR, ICU, CCU)

 Technicians are required to help the armacist answer phones, prepare first doses, load medication drawers (24-hour supply), and prepare unit dose

Inpatient pharmacy requires the ability to prepare parenterals, hyperalimentations,

 Inventory technician, robot filler, IV technician, chemotherapy technician anticoagulant technician, clinical technician, supervisory technician

- ٠ Pharmacy robot fillers and other forms of pharmacy automation often look a lot less spectacular than they sound, but they can greatly reduce the amount of manual, repetitive labor that used to be required of technicians.
- Automated dispensing systems fill hundreds of prescriptions an hour. They are loaded with many of the most common drugs and dosages

Outpatient Setting Requirements

•

- Outpatient pharmacy is most difficult task because of front-line interaction with patients on a daily basis
- Job tests communication skills and stress level
 High volume of interacting on the
- telephone, taking in refill prescriptions, answering insurance questions

Outpatient Setting Requirements (Continued)

- Insurance billing technician, retail technician, stock inventory technician, technician recruiter, technician trainer
- Larger retail pharmacies might hire for the specific positions listed, but a pharmacy technician in a small pharmacy will probably do all of these duties.

Although customer interaction is time consuming and demanding, it

can also be rewarding to see the end result of your work.

Home Health Settings Requirements

- A home health pharmacy fits somewhere between an inpatient and an outpatient pharmacy
- Technicians process medications for patients on a weekly or monthly basis
- There are no patients, doctors, nurses, or other health care providers in this pharmacy
- In what kinds of situations might home health care services be needed?

Peritoneal dialysis and hospice care are two common home health care needs. Patients might also receive physical or occupational therapy at home.

• About 7.6 million people are served by home health agencies each year.

Mail Order Pharmacy/E-Pharmacy

- These types of pharmacies provide for common acquired illnesses specific to older people
- Large buildings in industrial areas that are used to process new or refill prescriptions
 New area of pharmacy that is steadily growing
- Many insurers allow patients to use a specified mail order pharmacy to obtain a three-month supply of a prescription.
- The FDA is still developing ways to regulate and ensure the safety of online pharmacies

• These four groups worked together to create the PTCB

National Certification for Technicians

 Pharmacy Technician Certification Board (PTCB) administers the certification exam three times a year in all 50 states
 Four major societies developed guidelines to gauge technicians: ASHP, APHA, ICHP, MPA

National Certification for Technicians

- Not all states' requirements for technicians are standardized
 Most, if not all, require technicians to have a high school diploma
- a high school diploma
 A technician who has passed the 100question exam can use the title Certified
- Pharmacy Technician and place the letter CPhT behind his or her name

Opportunities for Technicians

- Proper educational training (AS or BS in computer science) can lead to writing software or supplying support
- Can also write curricula, articles, and books for technician training
- Completion of a training program that offers a degree, such as a certificate, diploma, AA, AS, BA, or BS

A CPhT's certification can also be revoked if he or she is later convicted of a felony

Another requirement for national certification is no felony

• These characteristics are the expected professional standards for certified technicians, not the requirements for certification itself

• In a growing field, there are usually many opportunities for research, technical support, education, publishing, and development.
